**Art-Reach Partners with VSA arts of Delaware and the  
Delaware Division of the Arts to Promote Cultural Accessibility**  
*Delaware Arts Organizations Receive Free Listings in Online Access Guide*

**Art-Reach**, the nonprofit organization that facilitates access to the arts for people with disabilities and economic disadvantages throughout the Delaware Valley, has launched a unique partnership with **VSA arts of Delaware** and the **Delaware Division of the Arts** to promote the physical and programmatic accessibility of Delaware arts organizations and cultural venues.

Through this partnership, nonprofit Delaware arts organizations can receive a complimentary site visit evaluating the accessibility of their facilities against the guidelines of the American with Disabilities Act, as well as a complimentary listing on the online version of **Art-Reach**'s award-winning Access Guide, available at the Art-Reach website at [www.art-reach.org](http://www.art-reach.org).

In addition to the site visit and listing, participating arts organizations will also receive a written report of site-visit findings and a detailed guide on how to improve accessibility. The **Delaware Division of the Arts** is underwriting the cost of the accessibility site visits, which will be conducted by **VSA arts of Delaware**.

“The Access Guide is the Delaware Valley’s premier resource on cultural accessibility,” said **Art-Reach** Executive Director Michael L. Norris. “It gives people with disabilities and their friends and families the information they need to participate in the rich cultural life of our region. The Access Guide already contains entries on nearly 140 cultural venues and other resources for the disability community, and we are excited about expanding it to include Delaware.”

Published in 2000, the Access Guide was converted to an online format in 2002. “The website version allows us to expand and update the information in the guide very easily and quickly,” said Norris, “and it also allows people to link right through to each venue’s own website for more information.” Each entry in the Access Guide includes a detailed description of that cultural venue’s physical and programmatic accessibility features, as well as general information about mission, hours and admission.
